COMPLAINT

Now comes the plaintiff, CANDICE WU COUTURE, INC. ("Wu"), through counsel, to allege and complain of defendant as follows:

PARTIES

- 1. Plaintiff Wu is a Massachusetts corporation, with a usual place of business at 460 Harrison Ave, Boston, MA 02118. Wu is a bridal boutique.
- 2. Defendant Boston Water and Sewer Commission ("BWSC") is a quasi-government agency of the City of Boston. It was established in 1977 pursuant to a "home rule" petition enacted by the Massachusetts State Legislature as the Boston Water and Sewer Reorganization Act of 1977, Chapter 436 of the Acts of 1977 on July 18, 1977. BWSC's principal place of business is at 980 Harrison Avenue, Boston, MA 02119.

JURISDICTION AND VENUE

- 3. This Court has jurisdiction over this matter.
- 4. Venue in this court is proper.

FACTS COMMON TO ALL COUNTS

- 5. The building located at 460 Harrison Ave is part of a neighborhood in Boston's South End called SoWa. SoWa is the heart of Boston's art and design scene, as well as a chic dining destination and vibrant residential community.
- 6. On or about April 14, 2020, a 30-inch diameter water main, first installed in 1915 (the "Water Main") failed at 500 Harrison Ave, Boston, MA 02118, causing a flood at Plaintiff's shop at 460 Harrison Ave, where the Plaintiff's inventory and property were located, causing damage to the Plaintiff's inventory and property.
- 7. At the time of the flood, Wu owned and/or operated a thriving bridal boutique business within the SoWa neighborhood.
- 8. BWSC owns, operates, and controls the water, sewer, and storm drain systems within the City of Boston pursuant to Chapter 436 of the Acts of 1977 (the "Enabling Act").

 This includes the operation and maintenance of the Water Main.
- The Enabling Act and BWSC's General Revenue Bond Resolution, adopted December
 1984, together require BWSC to annually develop a three-year Capital Improvement
 Program ("CIP").

- 10. In its CIP for 2020-2022, published in November 2019, BWSC outlined a "Water Main Replacement Program" in which it identified, and prioritized for replacement, water mains "that have reached the end of their useful life."
- 11. The Harrison Avenue water mains, including the Water Main, were identified as the top priority for replacement in the Water Main Replacement Program out of all the water mains maintained and operated by BWSC. This priority list was based on "information and recommendations from the 2016 update of the pipe ranking system as well as water main breaks; customer complaints concerning water quality or pressure deficiency; BWSC maintenance records, pressure and fire-flow tests; and construction work planned by other agencies."
- 12. Although the CIP was published in November 2019, construction on the Harrison Avenue water mains was not scheduled to begin until April 2021 despite those same water mains being identified as "hav[ing] reached the end of their useful life."
- 13. On April 14, 2020 at around 9:30 PM, BWSC received a call from a member of the public reporting that water was surfacing at Harrison Avenue and Perry Street in the South End of Boston.
- 14. The Water Main, a 30-inch cast iron water main in the Southern High Service network of BWSC's water delivery system, had given way and rapidly begun to flood the area at an average rate of over 55,000 gallons per minute.

- 15. A BWSC crew was dispatched to the area, but did not bring the flow of water to a halt until 12:30 AM, three hours after the initial report of water surfacing.
- 16. The results of this water main break were immediate and catastrophic. A total of approximately 6.15 million gallons of water flooded the surrounding streets and buildings, buckling the pavement of Harrison Avenue as it went. Residents of nearby apartment and condominium complexes were evacuated from their homes, while cars parked on Harrison Avenue were flooded and, in some cases, completely submerged due to the collapsing pavement and rising water.
- 17. As a result of the failure of defendant BWSC to secure its premises or maintain it in a safe and satisfactory condition, on or about April 14, 2020, due to the actions or inactions of BWSC, its agents, servants or employees, a 30-inch diameter, cement-lined iron water main failed at 500 Harrison Ave, Boston, MA 02118, causing a flood to occur at Plaintiff's shop, and the Plaintiff sustained water and other damages to its inventory and property.
- 18. On or around June 26, 2020, Plaintiff presented its claims in writing to BWSC in compliance with the requirements set forth by M.G.L. c. 258, § 4. A true and correct copy of Plaintiff's presentment letter is attached hereto as Exhibit A.
- 19. Since the date of the Plaintiff's presentment letter, more than six months have elapsed, and BWSC has failed to either deny Plaintiffs' claims in writing or reach final arbitration, settlement, or compromise of those claims.

COUNT I - NEGLIGENCE

- 20. Plaintiff Wu hereby re-alleges each and every allegation contained within paragraphs 1
 19, supra, as if specifically set forth herein.
- 21. Defendant BWSC owed a duty of care to Plaintiff to exercise reasonable care in maintaining, operating and repairing the Water Main.
- 22. BWSC breached that duty by, without limitation:
 - a. failing to properly maintain the Water Main;
 - b. failing to repair or replace the Water Main despite knowing that the Water Main was over 100 years old and "past [its] useful life;"
 - c. allowing an unusually high volume of water to enter the Water Main on the night of the flood, which exacerbated the damage caused by the flood; and
 - d. delaying shutoff of the water supply to the Water Main for three hours, which further contributed to the flood;
- 23. As a direct and proximate cause from this breach, Plaintiff has suffered damages in an amount to be proven at trial.
- 24. The damages suffered by Plaintiff were a foreseeable result of BWSC's negligence.

COUNT II - GROSS NEGLIGENCE

- 25. Plaintiff Wu hereby re-alleges each and every allegation contained within paragraphs 1
 24, supra, as if specifically set forth herein.
- 26. Defendant BWSC owed a duty of care to Plaintiff in maintaining, operating and repairing the Water Main.
- 27. Defendant BWSC breached its duty of care, causing the Water Main to fail and exacerbating and contributing to the subsequent flood.
- 28. Defendant BWSC acted with heedless and careless indifference towards its duty of care.
- 29. Defendant BWSC, its agents, servants or employees were grossly negligent toward the Plaintiff.
- 30. As a direct and proximate cause from this breach, Plaintiff has suffered damages in an amount to be proven at trial.
- 31. The damages suffered by Plaintiff were a foreseeable result of BWSC's gross negligence.

PRAYER FOR RELIEF

WHEREFORE, Plaintiff respectfully requests that this honorable Court:

- A. Enter a judgment in favor of Plaintiff in an amount to be proved at trial;
- B. Award costs and reasonable attorneys' fees; and
- C. Award Plaintiff any other relief that is proper and just.

PLAINTIFF HEREBY DEMANDS A TRIAL BY JURY FOR ALL ISSUES SO TRIABLE.

Dear Mr. Vitale:

Please be advised that this firm represents claimants Candice Wu ("Wu") and Candice Wu Couture, Inc. ("CWC") (collectively "Claimants") of 460-C Harrison Avenue, Suite C-3, Boston, MA, 02118 in relation to the substantial damages Claimants suffered to their inventory and property due to the flooding of Claimants' wedding dress boutique proximately caused by the Boston Water and Sewer Commission (BWSC)'s negligence in failing to maintain, care for, and repair its defective water main which ruptured overnight in the South End on April 14–15, 2020. An itemized <u>Damages Addendum</u> of Claimants' damaged property totaling \$344,144.00 is attached hereto as <u>Exhibit 1 - Damages Addendum</u> and incorporated by reference. Please accept this letter as formal presentment of Claimants' claims pursuant to G.L. c. 258, § 4 of the Massachusetts Tort Claims Act (MTCA) and a presentment notice of claim.

FACTS & LIABILITY

On the night of April 14, 2020, the Boston Police Department (BPD) was dispatched to 500 Harrison Avenue in Boston. Upon arrival, Officer Kevin Melay, along with Officers McMorrow and Canty, and Sargent Wright, were notified by O'Brien and Gillis of the Boston Fire Department (BFD) "that there was a water main break that occurred at the intersection of Harrison Avenue and Perry Street." ("Harrison-Perry Intersection"). Soon thereafter, the BWSC, Boston Emergency Medical Services (BEMS), National Grid, Eversource, BFD Hazmat, and Boston Public Works (BPW) were also dispatched to the scene. There was an excessive amount of water, and BWSC shut off the water main. Early the next morning on April 15, 2020, BPD Officer Garrett Boyle responded to the Harrison-Perry Intersection to assist on the

water main break, where he was advised that two vehicles had fallen into and had to be towed out of the resulting sink hole. Off. Boyle reported that "[a] large amount of water had flooded the area around the intersection of Perry St and Harrison Ave."²

BWSC owed Claimants a duty to maintain, care for, and repair the water main.

BWSC owned, controlled, and had responsibility for the aforementioned portion of the water main at the Harrison-Perry Intersection on the date it ruptured and flooded CWC's place of business, and therefore owed Claimants a duty to maintain, care for, and repair the water main, and "is responsible for damages which accrue to individuals through negligence in the construction, maintenance or operation of its system of sewers."

BWSC breached its duty of care by failing to maintain, care for, and repair the water main.

BWSC breached this duty by failing to act to repair and maintain the water main before it ruptured and flooded CWC's place of business. Significantly, BWSC also had prior actual knowledge that the water main reached its "useful life" which it stated in its own planned project to replace the water main. BWSC also knew the water main was old and has not been rehabilitated in many years, as later on the same day at the scene of the ruptured water main, BWSC Spokesman Tom Bagley described the ruptured water main to NBC Boston, "it's an older main, it was put in in 1915, [BWSC] rehabilitated it in 1972." 5

BWSC's breach of duty proximately caused Claimants' damages.

BWSC's aforementioned negligent breach of duty was the actual and proximate cause of the substantial damages Claimants suffered to their inventory and property, because but for BWSC's breach of duty to reasonably maintain, care for, and repair the water main in working order, the water main would not have ruptured and then consequently flooded Claimants' wedding dress shop with water, and then soaked and

destroyed their inventory and property, which was a reasonably foreseeable risk of injury due to a governmental sewer commission failing to reasonably maintain a large water main in working order located in one of Boston's main business and shopping districts. BWSC's negligence in this case is clear.

As a direct and proximate result of BWSC's aforementioned negligence, Claimants suffered substantial property damages to and destruction of their inventory and property totaling \$344,144.00 as of the date of this claim as further documented on the attached itemized Damages Addendum and the enclosed photographs corresponding to each damaged item.

Claimants do not have any insurance to cover this damage, and common sense suggests Claimants will be able to establish BWSC was negligent and caused Claimants' damages.

DEMAND

In light of the aforementioned negligence of the BWSC arising from when it breached its duty to reasonably maintain, care for, and repair the water main at the Harrison-Perry Intersection in working order and resulting water main rupture which consequently flooded Claimants' wedding dress shop with water and substantially damaged and destroyed their inventory and property, Claimants respectfully demands the sum of \$344,144.00 as damages in settlement of this claim.



WATER REPLACEMENT

The following pages contain brief summaries of each on-going and new water replacement projects included in the 2020-2022 CIP.

NEW PROJECTS

Water Main Replacement in Harrison Ave, South End – Contract No. 20-308-001: This project includes the replacement of older cast iron water mains that have reached their useful life in Harrison Ave, South End. Construction is projected to commence April 2021 and be completed by November 2022. The total three-year budget for this project is \$1,000,000.

Water Main Replacement in Shawmut Ave, South End – Contract No. 20-308-002: This project includes the replacement of older cast iron water mains that have reached their useful life in Shawmut Ave, South End. Construction is projected to commence April 2021 and be completed by December 2022. The total three-year budget for this project is \$1,100,000.

Water Main Replacement in Charlestown – Contract No. 20-308-003: This project includes the replacement of older cast iron water mains that have reached their useful life in Charlestown. Construction is projected to commence April 2021 and be completed by November 2022. The total three-year budget for this project is \$1,000,000.

Water Main Replacement in City Proper / Charlestown – Contract No. 20-308-004: This project includes the replacement of older cast iron water mains that have reached their useful life in City proper / Charlestown. Construction is projected to commence April 2021 and be completed by December 2022. The total three-year budget for this project is \$500,000.


<u>Water Main Replacement in City Proper – Contract No. 20-308-005</u>: This project includes the replacement of older cast iron water mains that have reached their useful life in City Proper. Construction is projected to commence April 2021 and be completed by December 2022. The total three-year budget for this project is \$850,000.

<u>Water Pipe Replacement Portion - South Boston Sewer Separation Contract No. 22-309-012 Contract 3:</u> This project includes the water pipe replacement portion of the South Boston sewer separation Contract III. Construction is scheduled to commence in June 2022 and is projected to be completed by September 2023. The three-year budget is \$450,000.

Final Paving - South Boston Sewer Separation Contract No. 20-309-011P Contract 1: This project includes the final Paving for South Boston Sewer Separation Phase I. This project is one of two (2) planned contracts to install final pavement where new storm drains have been constructed in Phase 1 and 2 to separate approximately 400 acres in South Boston along the Dorchester Avenue Corridor. New paving will also be installed where upgrades of the sanitary sewer and water main systems impact the roadway surface. Construction is scheduled to commence in April 2021 and is projected to be completed by July 2024. The three-year budget is \$750,000.









Boston's South End Recovering After Water Main Break Floods Streets, Buildings

One interior designer estimated \$1 million in damages after the water main break flooded her office, requiring the fire department to free her

Repairs continued into Wednesday after a massive water main break caused a mess the night before in Boston's South End.

Boston's South End neighborhood was recovering Wednesday after a water main break flooded streets and buildings and forced residents to evacuate despite social distancing measures in place.

The leak, caused by an overpressurized water line, submerged vehicles and caused the road to buckle near 500 Harrison Ave.

"It's significant. There's probably 10 or 15 cars underwater. Basements that are full of water," said Tom Bagley from the Boston Water and Sewer Commission.

At least one car had to be pulled out of a sinkhole that formed during the flooding.

"We came out on the deck and there was water everywhere. It was a lake," explained Julie Saidenberg who had to evacuate her home.

Though the water had dissipated and service was eventually restored, crews were working Wednesday to repair the 30-inch pipe. Officials said residents could be without power for at least 24 hours during the repairs.

It's unclear what caused the main to break but authorities said it was on the older side.

"It was put in in 1915. We rehabilitated it in 1972," Bagley explained. "Why it happened needs to be determined."

Meichi Peng, an interior designer, struggled to escape her office after the flood forced the door shut.

"I had to call 911," Peng said. "They put me through to the fire department not knowing they were already standing outside."


In water up to her waist, Peng, who owns the Meichi Peng Design Studio, wrote her cell phone number down on a sheet of paper and put it up to the window for firefighters to see. They helped her safely out of the building.

Peng was in a meeting when she heard the sound of running water but didn't think much of it until a parking attendant tapped on her window and told her to get out. By the time she turned around, she

said, she saw the water pouring inside but she couldn't get out because the water was already four feet high and the door was forced shut.

The interior designer took a video on her cell phone of the water rushing into her South End business on the basement level. She estimates at least one million dollars in damages.
